

### **Program Description**

The mission of Junior Leadership Pulaski County (JrLPC) is to inspire the next generation to be community influencers by becoming their best selves now.

#### **Program Goals**

- To encourage students to realize their own potential and develop their leadership skills.
- To develop young leaders who will be challenged to apply their new skills through interactions with community leaders, decision makers, and peers from other schools in the area.
- To create an environment that nurtures potential young leaders to participate in school/community service and volunteerism.
- To increase personal and community awareness.

#### **Eligibility/Application Criteria**

- Students must be a sophomore or junior (ages 15-17) in high school during the 2024-2025 school year.
- Students must complete an application and submit a letter of recommendation.
- Pay a \$25.00 program fee (due upon acceptance, before July 5, 2024). No school should accept
  payment, invoices will be mailed to students upon acceptance to program and payments will be
  submitted to the LPC Alumni Foundation.

Registration is open to 2024-2025 school year sophomore and junior students of all high schools in Pulaski County. JrLPC is limited to 16 students per class. Selection criteria include:

- Desire for personal growth
- Interested and motivated to serve school and community
- Drawn to volunteerism, resulting in positive change
- Ability to commit to program attendance and participation requirements
- Selection is based upon thoroughness of answers on the candidate's application and recommendations

#### **Program Schedule**

#### **Rules of Conduct and Commitment**

#### 1. ATTENDANCE

Attendance at the Welcome Dinner and Orientation is mandatory. Attendance at all sessions is expected. **Check session dates prior to submitting the application to ensure you meet the attendance requirement.** 

#### COMMITMENT

Junior Leadership Pulaski County is a 7-month commitment. Sessions are held once a month. It is important to be on time for each session, remain until the session is ended, and agree to leave the facilities at scheduled times only. Commitment to the program is essential to successful completion.

#### 3. CONDUCT

Conduct yourself and dress in a manner appropriate to Junior Leadership Pulaski County standards (guidance will be provided for each session). Use your school dress code as guidance for attire. Show the proper respect to all speakers and facilitators. Participate in class activities and discussions and ask questions.

#### 4. PROGRAM FEE

Program Fee for each participant of Junior Leadership Pulaski County is \$25 which will cover all materials, meals, class shirt, and other expenses. Fee is due upon acceptance and must be paid in full before the beginning of the first session. Scholarships are available for students who qualify.

#### 5. CELL PHONE/PHONE CALLS

Be respectful of our speakers and facilitators, as well as other class members. All cell phones should be turned off. There will be scheduled breaks and transition times you may utilize to make necessary phone calls. #### 6. FAMILY/GUEST VISITS

Refrain from having friends or family visit during sessions. Under no circumstances will guests be allowed to participate in class activities. Each participant may invite parents or guardians to the graduation ceremony.

Personal vehicles are allowed but will not be allowed during scheduled class tours, if any. The Chamber will provide any transportation needed during class tours during which all students must ride on vehicles provided by the Chamber.
